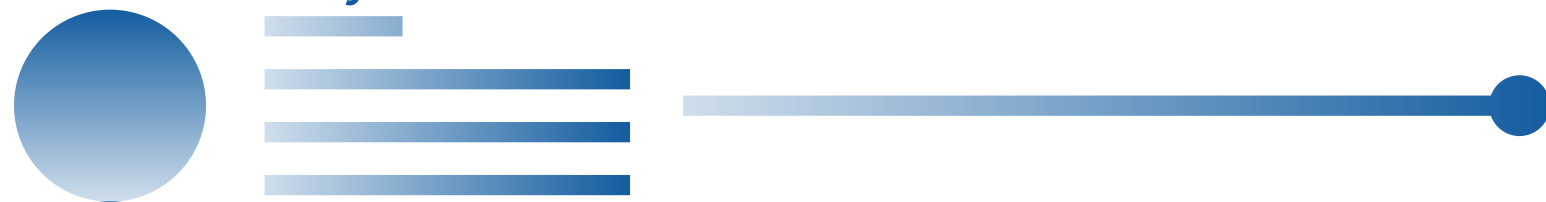

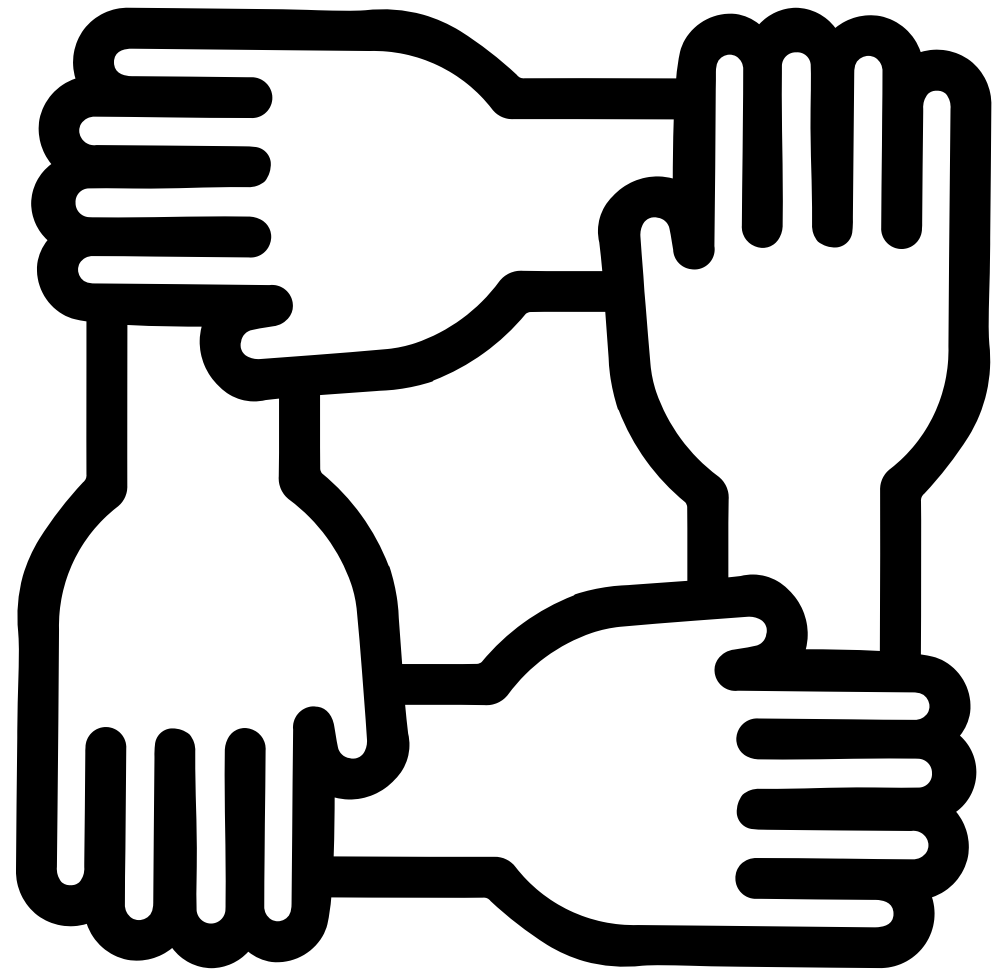

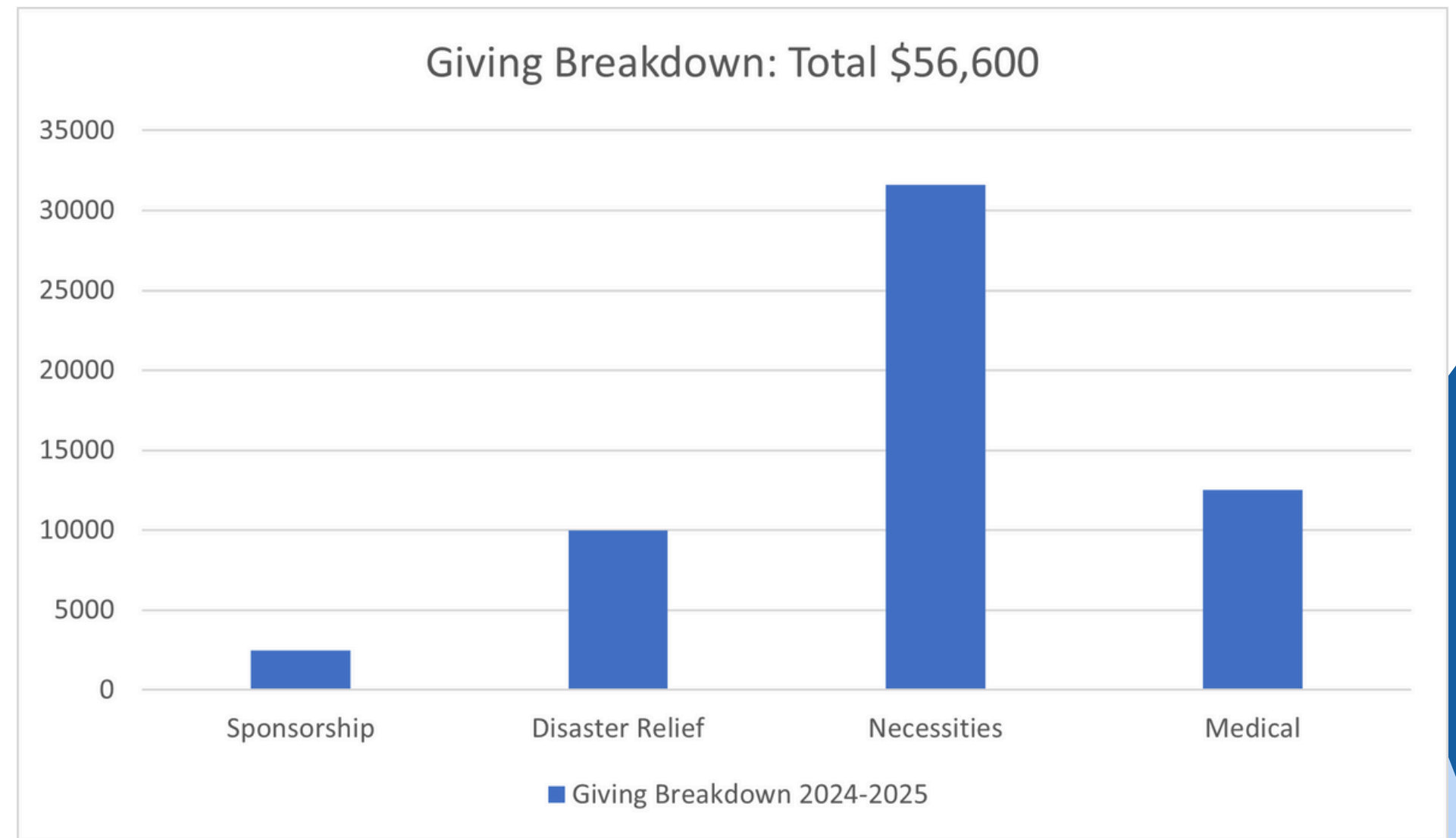
OUR STRATEGIES

FIRST YEAR GIVING

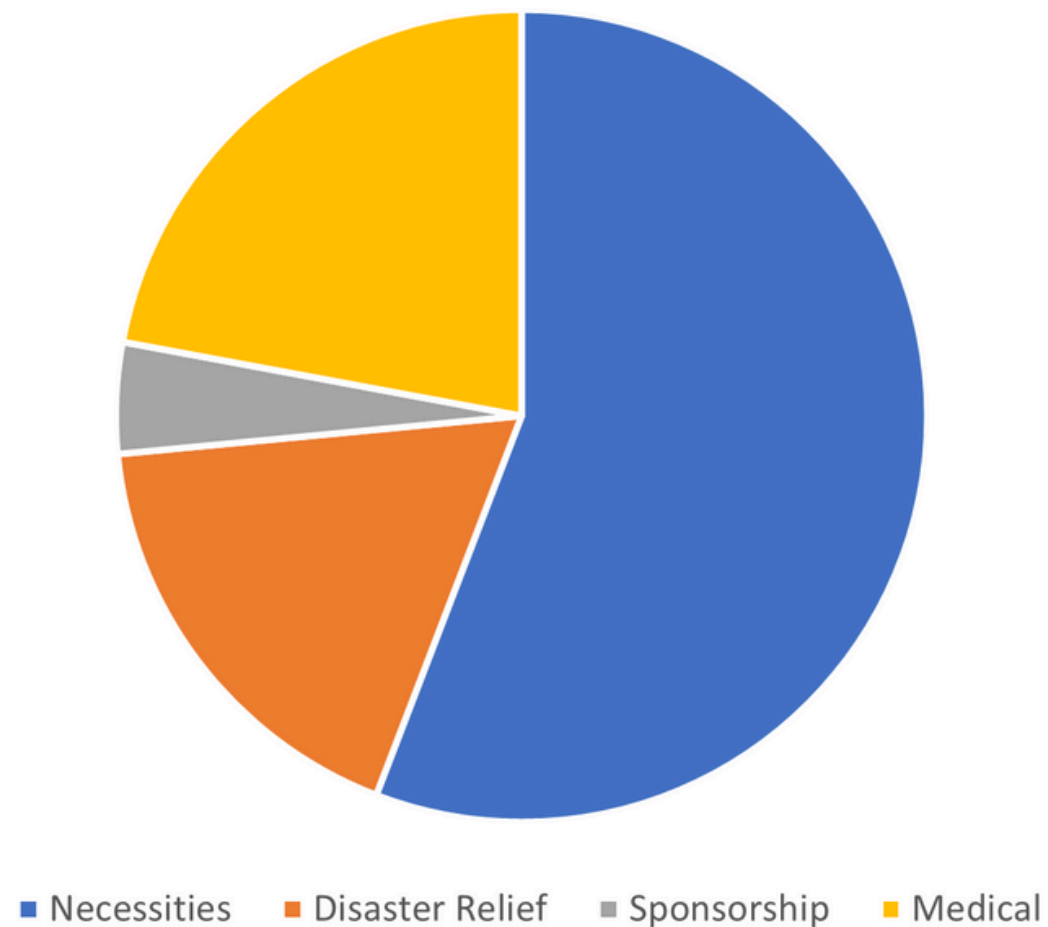

Some examples of the assistance that we have provided this year are providing:

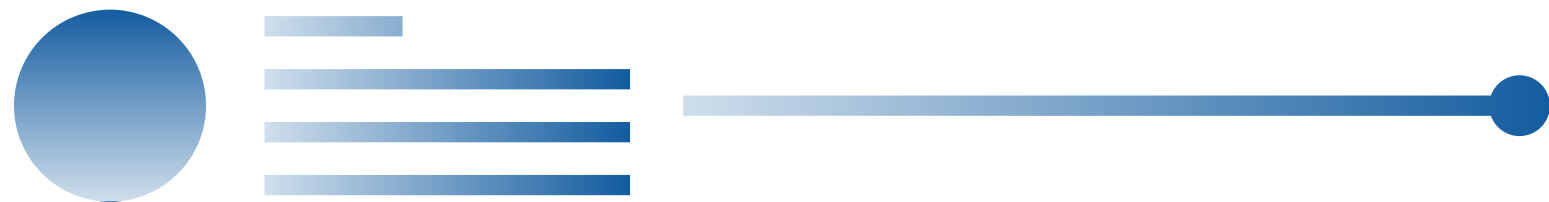

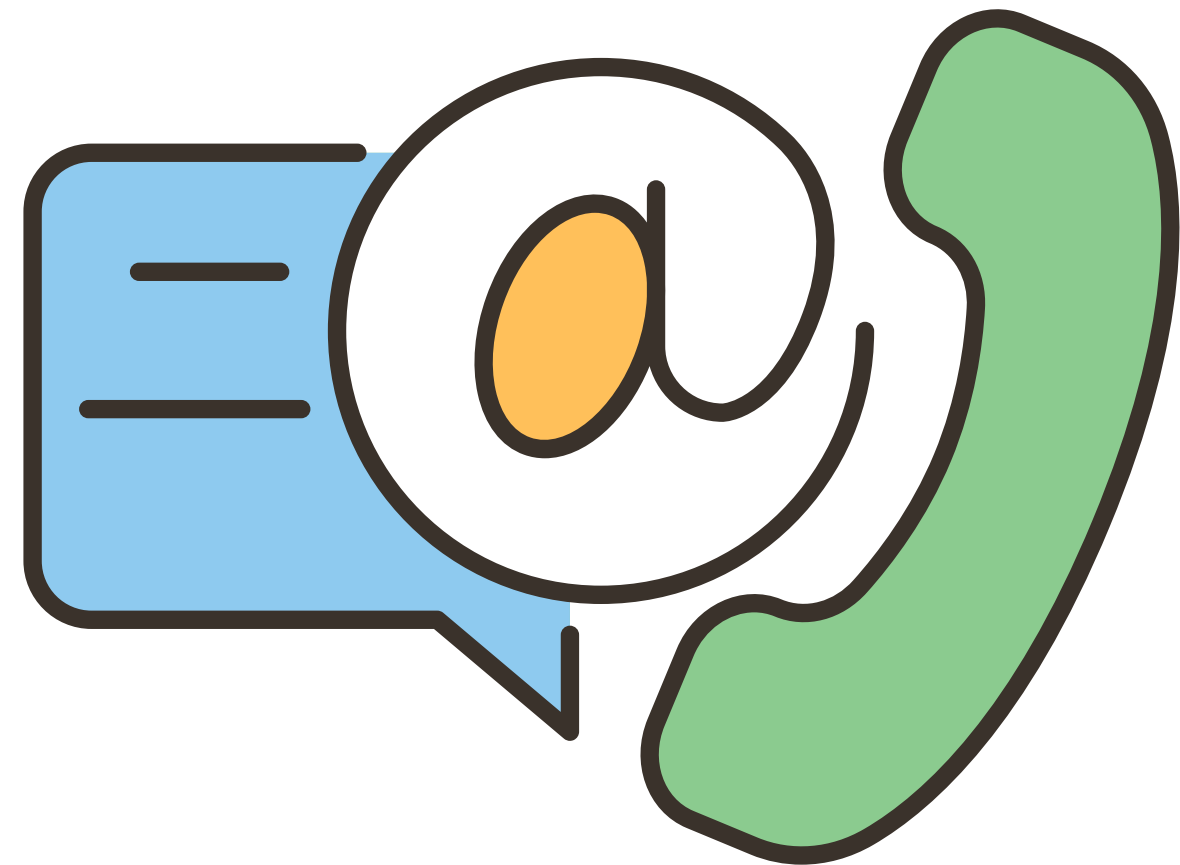
